Overview

This report describes 1) a review of the professional certifications and state professional standards generally applicable to the ranks of Fire Chief and Fire Captain in the State of California to determine the standards that would, therefore, be considered requirements for the Fire Captain, Correctional Institution (9001) and Fire Chief, Correctional Institution (8976) classifications of the California Department of Corrections and Rehabilitation (CDCR); and 2) a comparison of the occupational analysis results to the current minimum qualifications for each classification, as well as to the proposed new minimum qualifications developed by CDCR subject matter experts to determine how the results link to, and therefore, support the use, or potential use, of the minimum qualifications. The first section of this report describes the professional certification and standards review; the second section of this report describes the minimum qualifications linkage process and results.

Fire Captain and Fire Chief Occupational Analyses

The Commission on Correctional Peace Officer Standards and Training (CPOST) entered into a contractual agreement with CPS HR for the provision of occupational analyses of the Fire Captain, Correctional Institution (9001) and Fire Chief, Correctional Institution (8976) classifications as used within the institutions of the CDCR. The goals of those studies, which were conducted between February 2020 and February 2021, were to identify the important job tasks and the relative importance of those tasks, on average, for Fire Captains and Fire Chiefs in the institutions of the CDCR; and to identify the knowledge, skills, and abilities (KSAs) that are required for successful performance of those tasks, the relative importance of each KSA, and if each important KSA must be possessed on the first day on the job at an institution, or sometime after placement in the job. The results of the occupational analyses were used in both parts of the current study, as described in this report.

Part 1: Professional Standards Review

The purpose of this review was to identify the professional standards applicable to the ranks of Fire Chief and Fire Captain in the State of California, and particularly those that may be required by state law or the guidelines of applicable regulatory authorities, which therefore should be possessed by individuals in the CDCR's Fire Captain and Fire Chief classifications. This review consisted of gathering information from a variety of sources, including phone interviews with subject matter experts (SMEs) knowledgeable of the background and history regarding fire-related professional certifications and state standards, and online research related to State of California certifications and other requirements for the ranks of Fire Captain and Fire Chief. The online research utilized the following sources:

Fire Service Standards Authority in California

The California Department of Forestry and Fire Protection (CAL FIRE) provides fire protection and suppression, hazard mitigation, and disaster response for California's wildlands, as well as various emergency services in 36 California counties through contracts with local governments. The Office of the State Fire Marshal (OSFM) was established within CAL FIRE to support CAL FIRE's mission of protecting life and property through fire prevention engineering programs, law and code enforcement, and education. The OSFM is mandated by California Public Safety Code¹ to establish levels of certification for fire service personnel based on performance requirements in different job functions in the fire service, which it does through its State Fire Training (SFT) division.

SFT was established by the California Fire Service Training and Education Program Act² to enhance the coordination of fire service training and education, develop (in conjunction with the State Board of Fire Services) minimum standards for fire service personnel and fire service instructors, and establish and enforce standards for curriculum, training facilities, and faculty of

schools, seminars, or workshops operated by or for the state for the specific purpose of training fire service personnel.³ SFT training and certifications are based on the standards developed by the National Fire Protection Agency (NFPA), a non-profit agency that publishes widely-adopted codes and standards intended to minimize the possibility and effects of fire and other risks, including fire codes and training/certification standards for multiple levels and specialties of emergency response personnel.⁴ Over 45,000 individuals participate in SFT's educational and certification programs annually, and SFT has provided certifications to fire service personnel in over 900 California fire agencies.⁵

While the OSFM enforces regulations related to fire protection (e.g., Health and Safety Code, State Building Standards Code), based on the research conducted for this review, as well as the consensus opinion of the SMEs, neither the OSFM, nor the regulations that established it⁶ specify any legally mandated training, certifications, or job experience for any level of fire service employment. However, because the OSFM is considered to be the fire service standards authority for the State of California, their standards are based on the nationally recognized NFPA standards, and their standards have been adopted by numerous fire agencies throughout California as well as by CAL FIRE for their own fire service employment standards, OSFM/SFT standards should be considered to represent best practice in the California fire service.

OSFM/SFT Certifications Applicable to Fire Chief and Fire Captain

Fire Fighter 1 and 2

SFT established two certification levels covering basic fire fighting knowledge and skills: Fire Fighter 1 and Fire Fighter 2. These certifications are based on NFPA 1001, the standard for firefighter professional qualifications that identifies the minimum job performance requirements for firefighters whose duties are primarily structural in nature; NFPA 1051, which establishes standards for wildland fire fighting; and NFPA 1072, which establishes standards for hazardous materials awareness and operations. The Fire Fighter 1 certification is earned upon completion of an SFT-accredited fire academy, and is typically required for entry level firefighters. The Fire Fighter 1 certification covers multiple topics in the following areas:⁷

- Structure Fire Fighter Duties
- Fire Department Communications
- Fire Ground Operations
- Preparedness and Maintenance
- Hazardous Materials/WMD

- Wildland Fire Fighter Duties
- Wildland Fire Fighter Preparedness
- Wildland Fire Suppression

The Fire Fighter 2 certification (for which Fire Fighter 1 is a prerequisite) is typically earned by a firefighter after demonstrating successful performance of various job skills in the above areas, and also includes Rescue Operations and Fire and Life Safety Initiatives.8 Because Fire Captains and Fire Chiefs within CDCR perform fire suppression and rescue activities, and also train and oversee inmate firefighters performing fire suppression (often both structural and wildland), rescue activities, and potentially, hazardous materials response, possession of the SFT Fire Fighter 2 certification (or an equivalent demonstration of the knowledge and skills covered by the certification) should be considered a minimum requirement for the ranks of Fire Captain and Fire Chief at CDCR. 9 To illustrate this point, Appendix A lists the KSAs identified in the Fire Captain and Fire Chief occupational analyses as required for performing the job, that would likely be demonstrated by possession of the SFT Fire Fighter 2 certification. As shown in the first table in Appendix A, nine KSAs determined to be important for performing the job of a Fire Captain within CDCR would likely be demonstrated by possession of the Fire Fighter 2 certification; and as shown in the second table in Appendix A, 10 KSAs determined to be important for performing the job of a Fire Chief within CDCR would likely be demonstrated by possession of the Fire Fighter 2 certification.

Apparatus Driver/Operator

SFT has five certifications in the Apparatus Driver/Operator certification series covering the operation of different types of equipment (aerial apparatus, pumping apparatus, tillered apparatus, water tender, and wildland fire apparatus). As with the other SFT certifications, the Apparatus Driver/Operator certifications are based on NFPA standards. Fire Captains and Fire Chiefs within CDCR have varied responsibilities related to operating fire equipment, and depending on the type of equipment used at the institution of assignment, one or more of the SFT Apparatus Driver/Operator certifications would likely demonstrate possession of KSAs related to operating vehicles and fire apparatus. To illustrate this, the first table in Appendix B lists the KSAs identified in the Fire Captain occupational analysis that would likely be demonstrated by possession of an Apparatus Driver/Operator certification; and the second table in Appendix B lists the KSAs identified in the Fire Chief occupational analysis that would likely be demonstrated by possession of an Apparatus Driver/Operator certification.

Note that although the SFT Apparatus Driver/Operator certifications are not legally required for employment of a Fire Captain or Fire Chief, according to the California Vehicle Code, in order to qualify for a driver license firefighter endorsement, which is required for operating firefighting equipment in California, one must provide evidence of training consistent with either the NFPA standards, or the Fire Apparatus Operator training standards of the OSFM.¹¹

Hazardous Materials Technician and Specialist

SFT has two certifications related to hazardous materials response: Hazardous Materials Technician, which is intended for individuals involved in the planning, response, and handling of hazardous materials incidents; and Hazardous Materials Specialist, which is more focused on knowledge of specific hazards. The certifications cover the following topic areas:¹²

- Basic chemistry of hazardous materials
- Field identification of chemicals
- Incident considerations
- Tactical field operations
- Specialized mitigation techniques (Specialist only)
- Advanced field operations (Specialist only)

Four KSAs were identified in the occupational analyses for Fire Captain and Fire Chief that are directly related to hazardous materials response, handling, and inspections, and therefore, would likely be demonstrated by possession of the SFT Hazardous Materials certifications. Appendix C lists these KSAs for each classification (note that the KSAs are the same for both classifications).

SFT Officer Certifications

SFT has three levels of officer certifications (above the level of Firefighter and Apparatus Driver/Operator): Company Officer, Chief Fire Officer, and Executive Chief Fire Officer, which are intended to reflect increasing levels of oversight in a fire company or department, although SFT does not specify which fire service ranks (e.g., Fire Captain or Fire Chief) are most directly applicable to each. The certifications are based on NFPA officer qualification standards¹³ and cover multiple topics in the following areas:¹⁴

- Incident Management System
- Hazardous Materials Plan of Action
- Human Resource Management (includes assigning tasks and responsibilities, applying human resource policies and procedures, supervising, performance improvement)

- Community and Government Relations
- Administration (includes budgets, purchasing, incident response data)
- Inspection and Investigation
- Emergency Service Delivery
- Health and Safety
- Wildland Fire Officer

Although these certifications are not legally required, and therefore could not be considered employment requirements for the Fire Captain or Fire Chief classifications, possession of these certifications by a job candidate would indicate possession of a number of fire service related KSAs above the level of a firefighter or engineer, particularly those related to supervising and management. Appendix D lists the KSAs identified in each occupational analysis that would likely be demonstrated by possession of one or more of the SFT Officer certifications (17 KSAs for Fire Captain; 19 KSAs for Fire Chief). It should be noted that this is based only on a review of the certification topic areas, and not the full certification standards and training content. Therefore, the degree to which each KSA would be demonstrated by one or more of the Officer certifications cannot be determined from this review.

Legal Requirements

Driver License Fire Endorsement

The Occupational Analyses showed that Fire Captains and Fire Chiefs within CDCR are required to drive vehicles (both fire apparatus and non-apparatus vehicles) on and off institution grounds in response to emergency incidents. Under California law, these vehicles are considered "firefighting equipment," and as stated in the California Vehicle Code, anyone operating firefighting equipment must have a fire fighter endorsement on either a Class C license, or a Class B non-commercial license appropriate for the type of vehicle(s) driven. ¹⁶

First Aid/CPR Certification

California Health and Safety code states that all firefighters shall be trained to administer first aid and cardiopulmonary resuscitation (CPR),¹⁷ and Title 22 of the California Code of Regulations establishes the standards for that training for public safety personnel.¹⁸ Additionally, the Health and Safety Code defines a firefighter as "any regularly employed and paid officer, employee, or

member of a fire department or fire protection or firefighting agency of the State of California, a city, county, city and county, district, or other public or municipal corporation or political subdivision of this state or member of an emergency reserve unit of a volunteer fire department or fire protection district." Therefore, all Fire Captains and Fire Chiefs within CDCR must possess a First Aid/CPR certification.¹⁹

EMT Certification

Title 22 of the California Code of Regulations states that the attendant on an ambulance operated in emergency service, or the driver of the ambulance if there is no attendant, shall possess a current California EMT certification.²⁰ Some Fire Captains and Fire Chiefs within CDCR operate, or may be required to operate, an ambulance in response to emergencies, including off institution grounds. Therefore, an EMT certification should be required for applicable Fire Captain and Fire Chief positions.

Part 1 Summary

The purpose of this review was to identify the professional standards applicable to the ranks of Fire Chief and Fire Captain in the State of California, and particularly those that may be required by state law or the guidelines of applicable regulatory authorities, which therefore should be possessed by individuals in the CDCR's Fire Captain and Fire Chief classifications. Based upon the research outlined and documented herein, the only apparent legal requirements applicable to Fire Captain and Fire Chief are FF endorsement on Drivers Licenses, First Aid/CPR, and EMT for positions requiring driving an ambulance; and there are no known legally-mandated fire service certifications. As a result, it is apparent that employers of Fire Captains and Fire Chiefs should look to OSFM/SFT in the State of California as the standards authority on which to base their requirements for these classifications. In addition to the recommended requirements of OSFM/SFT, many other certifications/trainings, such as those outlined by the National Fire Academy; FEMA Incident Command courses; and the National Wildfire Coordinating Group (NWCG) could also be applicable as the basis for individual departments to establish their own requirements for these fire related classifications. Given the lack of overarching legallymandated fire service certification requirements, individual fire departments typically determine their own requirements for their fire related classifications based upon best practices, standards authority recommendations, and/or other recommendations based upon these entities. As a result of these findings, it is important that CDCR establish standards for these classifications that are consistent with best practices, and that their employees operating within the classifications

of Fire Captain and Fire Chief possess equivalent fire service expertise sufficient to perform the job, train and supervise inmate firefighters properly, and to reduce risk to the CDCR.

Part 2: Minimum Qualifications Linkage

The purpose of this phase of the current study was to compare the results of the aforementioned occupational analyses to the current minimum qualifications for each classification, as well as to the proposed revised minimum qualifications developed by CDCR subject matter experts, to determine the degree to which they link to, and therefore, support the use of the minimum qualifications.

Minimum Qualifications

Minimum qualifications (MQs) are statements of work experience, education/training, and/or licenses and certifications that indicate a job applicant likely possesses the knowledge, skills, and abilities (KSAs) that are important for successful job performance upon entry to the job (hire or promotion) at the level required for minimally acceptable job performance. MQs are not intended to differentiate minimally qualified applicants from better qualified applicants, but rather, to identify the applicants who should and should not continue on in the selection process.

The Current Minimum Qualifications

The current MQs, as stated in the California State Personnel Board Specifications, are as follows:

Fire Captain, Correctional Institution (9001)

- Education equivalent to completion of the twelfth grade; AND
- Two years of part-time experience performing the duties of an Institution Firefighter (Part Time) in a correctional facility of the Department of Corrections; **OR**
- One year of experience in structural fire fighting.

Fire Chief, Correctional Institution (8976)

- Education equivalent to completion of the twelfth grade; AND
- One year of experience performing the duties of a Fire Fighter, Correctional Institution, in the Department of Corrections; **OR**
- Three years of experience performing the duties of an Institution Fire Fighter (Part Time) in the Department of Corrections; **OR**
- Two years of experience in structural fire fighting.

Proposed Minimum Qualifications

As jobs and job requirements change over time, MQs should be revised to ensure they continue to serve their purpose of identifying applicants who do and do not possess the important KSAs

at the current minimum level. To this end, a group of Subject Matter Experts (SMEs), prior to this current study, developed new MQs for each classification to better reflect the current job requirements and keep up with fire service industry standards. Accompanied by a full classification and compensation study of the Fire Captain, Correctional Institution and Fire Chief, Correctional Institution classifications, these "proposed" MQs could be recommended to replace the above existing MQs.

The proposed MQs are as follows:

Fire Captain, Correctional Institution

- Completion of a California State Fire Training accredited fire academy AND possession of a State Fire Training Fire Fighter I certification;
- Possession of a California Class B Commercial Driver License OR a California Class C Driver License with a firefighter endorsement AND State Fire Marshal Driver Operator 1A & 1B certifications;
- Possession of a California Emergency Medical Technician (EMT) certification.
- Twenty-four months of full-time professional fire service experience at the level of Captain or higher; OR
- Thirty-six months of full-time professional fire service experience at the level of Engineer or higher; OR
- Forty-eight months of volunteer fire service experience at the level of Engineer or higher within the past five years.
- Candidate Physical Ability Test (CPAT) card and PC 832 training course are required upon appointment.²¹

Fire Chief, Correctional Institution

• Completion of a California State Fire Training accredited fire academy **AND** possession of a

- Possession of a State Fire Training Fire Fighter II certification;
- Possession of a State Fire Training Fire Officer certification;

State Fire Training Fire Fighter I certification;

 Possession of a California Class B Commercial Driver License OR a California Class C Driver License with a firefighter endorsement AND State Fire Marshal Driver Operator 1A & 1B certifications;

- Possession of a California Emergency Medical Technician (EMT) certification;
- Five years of full-time progressively responsible fire service experience with at least 36 months at the level of Captain or higher (all experience must be within the past seven years); OR
- Three years of experience as a Fire Captain or higher in a California State Correctional Institution (experience must be within the past five years).
- Candidate Physical Ability Test (CPAT) card and PC 832 training course are required upon appointment.

Minimum Qualifications Linkage Process

The adequacy of the current and proposed MQs was assessed using subject matter expert judgement regarding the likelihood that an applicant meeting each of the MQs would possess each of the KSAs identified in the occupational analyses. A meeting was convened on January 22, 2021, with the SMEs who developed the proposed MQs to review the current and proposed MQs compared to the occupational analysis results, and to begin the process of determining which of the occupational analysis KSAs are indicated by, or "link" to, each of the MQ statements. This process was started in the meeting, and then continued by the SMEs on their own, as described below.

In order to ensure that the SMEs fully understood the meaning and purpose of an MQ and therefore would be better able to perform this review, the SMEs were fist given the following definition of an MQ at the start of the meeting:

A minimum qualification statement typically describes:

- The amount of education or training that would indicate possession of the KSAs at the minimum level (type of degree, number of classes, number of class credits).
- The type of education or training that would indicate possession of the needed-at-entry KSAs (field of study, specific classes or training programs).
- The amount of work experience that would indicate possession of the KSAs at the minimum level (length of time).
- The type of work experience that would indicate possession of the needed-at-entry KSAs (type of work, positions, type of organization, specific responsibilities and duties).
- Any licenses, certifications, or other credentials that are required for the job, and/or would demonstrate possession of needed upon entry KSAs at the minimum level.

Each SME was then given a matrix for each classification (as Excel spreadsheets) that listed in a column on the left, all of the KSAs identified in the occupational analyses as important for performing the job of either the Fire Captain or Fire Chief, and determined to be needed upon

entry to each of the respective classifications (upon hire or promotion); and in a row across the top of the matrix, each current and proposed MQ statement. The SMEs were instructed to examine each KSA and determine if possession of each MQ would indicate that a job applicant meeting that MQ would likely possesses that KSA, at least at a minimally-acceptable level. If so, they were to place an X in the column below each MQ indicating that the KSA and MQ are linked. This process was started in the meeting as a group to ensure the SMEs understood the task, and then the SMEs were instructed to complete this process on their own.

Results

Current Minimum Qualification Linkages – Fire Captain

Table 1 shows the number of KSAs that linked to each of the current Fire Captain MQs, as well as the percentage of the total 112 KSAs that this number represents. This gives an indication of the general value of each current MQ in determining if a Fire Captain applicant possesses the KSAs at least at a minimum level. (Note that an applicant can qualify with either MQ statement.)

As Table 1 shows, either two years of part time institutional firefighting experience or one year of external (non-institutional) structural firefighting experience would indicate possession of just under half (45% and 44%, respectively) of the KSAs at a minimum level. Additionally, each MQ links to KSAs that the other MQ does not. These "unique KSA linkages" can indicate which MQ may be more valuable in determining a candidate's qualifications, depending on the relative importance of these unique KSAs.

Appendix E lists all of the Fire Captain KSAs and shows which ones link to each current MQ.

Current Minimum Qualification Linkages – Fire Chief

Table 2 shows the number of KSAs that linked to each of the current Fire Chief MQs, as well as the percentage of the total 122 KSAs that this number represents. This gives an indication of the general value of each current MQ in determining if a Fire Chief applicant possesses the KSAs at least at a minimum level.

As Table 2 shows, either one year of full-time institutional firefighter experience or three years of part-time institutional firefighter experience would indicate possession of approximately half (49% and 52%, respectively) of the KSAs at a minimum level; and two years of external (non-institutional) structural firefighting experience would indicate possession of 67% of the KSAs at a minimum level. One year of full-time institutional firefighter experience linked to one KSA the other MQs did not link to, and two years of external structural fire fighting experience linked to 31 unique KSAs. Nineteen of these unique KSAs are the entire set of physical abilities, none of which linked to either of the other two MQs.

Appendix F lists all of the Fire Chief KSAs and shows which ones link to each current MQ.

<u>Proposed Minimum Qualification Linkages – Fire Captain</u>

Table 3, on the following page, shows the number of KSAs that linked to each of the proposed Fire Captain MQs, as well as the percentage of the total 112 KSAs that this number represents. This gives an indication of the general value of each proposed MQ in determining if a Fire Captain applicant possesses the KSAs at least at a minimum level.

As Table 3 shows, a Fire Fighter I certification based on training from a California State Fire Training accredited academy would indicate possession of 28% of the KSAs at a minimum level (and no unique KSAs), whereas any of the three experience MQs would indicate possession of at least 74% of the KSAs, meaning that requiring a Fire Fighter I certification in addition to the required experience would not add value in terms of assessing the KSAs. This is not unexpected, as anyone with the stated experience would likely already possess a Fire Fighter I certification, which is typically required for entry level firefighters. Additionally, it is important to note that although the Class B Commercial Driver License with a firefighter endorsement linked to very few KSAs, and the California EMT certification linked to fewer KSAs than did the experience statements (and also did not link to any unique KSAs), both of these are legal requirements for the job, and therefore must be listed as MQs.

Appendix G lists all of the Fire Captain KSAs and shows which ones link to each proposed MQ.

Table 4, on the following page, shows the number of KSAs that linked to each of the proposed Fire Chief MQs, as well as the percentage of the total 122 KSAs that this number represents. This gives an indication of the general value of each proposed MQ in determining if a Fire Chief applicant possesses the KSAs at least at a minimum level.

As Table 4 shows, either of the of the two experience MQs would indicate possession of nearly all of the KSAs (96% and 98%), meaning that the certification requirements may not add value in terms of assessing the KSAs. As with the proposed Fire Captain MQs, the Class B Commercial Driver License with a firefighter endorsement, and the California EMT certification are legal requirements for the job, and therefore must be listed as MQs regardless of their predicted value in assessing the KSAs.

Appendix H lists all of the Fire Chief KSAs and shows which ones link to each proposed MQ.

Part 2 Summary

The purpose of this phase of the study was to compare the results of the occupational analyses to various minimum qualifications for each classification. This was done through a KSA linkage process that was designed to assess SME judgement of the degree to which the MQs would indicate that Fire Captain or Fire Chief applicants likely possess the KSAs needed for performing the job, and which are required upon entry to the job, as established by the occupational analyses. The linkage process was conducted for the current MQs for both classifications, as well as for the proposed MQs for both classifications that were developed (separately from this study) to better reflect the current job requirements and to be more consistent with current fire service industry standards.

Because MQs are typically used for screening job applicants to determine if they should continue in a selection process, the results of this MQ linkage can be used to assess the potential value of

each MQ in screening applicants, and inform decisions regarding which MQs should ultimately be used. For example, if trying to streamline an application review process by having as few individual MQs as possible, it would be advantageous to ensure the MQs are those that will indicate possession of the largest number of KSAs. This can be achieved for the Fire Captain and Fire Chief classifications by considering the number of KSAs that link to each MQ as shown in Tables 1-4 in this report.

It is also important to ensure that the MQs will indicate possession of the most important KSAs in order to better identify qualified applicants and enhance the quality of the candidate pool entering the selection process. Therefore, in assessing the value of the current and proposed MQs for Fire Captain and Fire Chief, consideration should be given to the relative importance of the individual KSAs that link to each MQ, as shown in Appendices E, F, G, and H.

Finally, while the results of this MQ linkage process can provide validation evidence for the current and proposed MQs for the Fire Captain and Fire Chief classifications, they can also be used to help justify the adoption and use of the proposed MQs by showing the extent to which they would indicate possession of the important KSAs for each classification over and above the current MQs. It is important to note however, that while this study provides evidence of the value of the proposed MQs, establishing the new MQs that will be used for screening job applicants requires a formal process beyond the scope of this study, which would include conducting a full classification and compensation study.
